

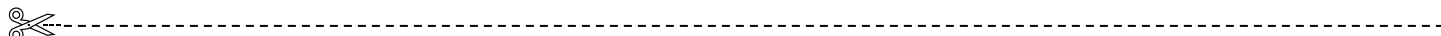
# GHIA Fall Artists' Market | September 10 – October 8, 2021

After being closed for over a year due to COVID-19, the Gertrude Herbert Institute of Art is back! We were unable to have our annual Spring Artists' Market in 2020 or 2021 and there was not enough time to plan the annual Juried exhibition, *A Sense of Place*, for September. So why not have a Fall Artists' Market instead? It is a great way to have some fun and gather with our friends and an even better opportunity to sell some artwork before the holidays.

A returning component of this year's Market is the **Artists' Boutique**, a gallery section featuring smaller works attractively priced at \$100 or less—the perfect place to find an artful and affordable treasure. Larger and higher priced artwork will hang in the Main Gallery and hallway.

- To display artwork in the **Main Gallery and/or Boutique**, join or renew as a GHIA Artist Member – memberships start as low as \$30 for the year – update online at [ghia.org](http://ghia.org), by mail, or by calling 706-722-5495. Your membership supports GHIA and everything we do – thank you!!
- Choose up to **four (4) original works** of art for inclusion in the Main Gallery and **five (5) smaller works** for inclusion in the Boutique. Works should be created in the past two years and never shown before at the Institute.
- Deliver artwork to the Institute on or before **Friday, August 27** between 10:00 a.m. - 4:30 p.m. Please include a completed inventory list with your artwork. 2D work needs to be wired and ready to hang.
- Original art in the following media are accepted: jewelry, pottery, sculpture, photography, drawings, mixed media, pastel, paintings, hand-pulled prints, and fine crafts such as basketry and tapestry.
- Work not sold can be picked up from the Institute between 10:00 a.m. – 4:30 p.m., **October 4 – 8, 2021**.
- **There will be an opening reception** with food and wine on **Friday, September 10, 2021, 6 – 8 p.m.** – Free to the public!

The Gertrude Herbert staff will handle all sales and collect 8% sales tax. Artists will receive 65% of the selling price. Sales over \$500 will require a W9 to be filled out by the artist.
